## Brandy Download Sweepstakes

### **OFFICIAL SWEEPSTAKES RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE A PARTICIPANT'S CHANCES OF WINNING.

### SWEEPSTAKES DESCRIPTION:

The "Brandy Download" sweepstakes ("Sweepstakes") will begin on Monday, October 29, 2012 and end on Sunday, November 4, 2012 ("Sweepstakes Period"). This Sweepstakes will be conducted via text message. One hundred and ninety eight (198) winners will each be awarded a digital download of Brandy's new album "Two Eleven" and three (3) of those winners will each be awarded one (1) pair of Monster Headphones ("Prize").

### HOW TO ENTER / EXECUTION:

Legal residents of the 48 contiguous United States who are (18) years of age or older residing within the metropolitan area of one of the participating radio stations (listed below) will be able to take part in this Sweepstakes. To participate in the Sweepstakes, participants must do the following:

- 1. Sweepstakes participants must text keyword "BRANDY" to 80185 when prompted by the on-air announcement. Standard text and data rates will apply.
